Events over the past year have greatly increased the risk these companies face due to climate change. Despite intense engagement efforts, these companies have refused to assess and disclose to investors how their portfolios will fare in a lower-carbon world. Given the importance of this issue to the long-term financial health of these companies, and the resistance shown so far to engagement, we believe it is critical for the companies to see just how broadly these concerns are shared.

As a result, we are coordinating a public declaration process for those who hold shares in these companies and wish to declare an intention to vote in favor of the resolutions. This process will take place in the run up to the annual general meetings. This is a similar strategy to build support for the resolutions as the one employed with great success by the Aiming for A coalition for the BP and Shell resolutions last year.

There will be two declaration dates for these U.S. resolutions—**April 8** and **May 6**, and we welcome all support for the resolutions. We will be publicizing these declarations in multiple media outlets to build support and raise awareness of the importance of this issue.
